

Protecting your private information is our priority. This Statement of Privacy applies to <https://deeperwalkinternational.org/> and Deeper Walk International and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Deeper Walk International include <https://deeperwalkinternational.org/>, DWI, The Deeper Walk Path and <https://thedeeperwalkpath.org>. The DWI website is a non-profit organization providing free and paid resources through events, ecommerce and online streaming videos & audio site. By using the DWI website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, DWI may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Company name (optional)

If you purchase DWI's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

DWI may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

DWI collects and uses your personal information to operate its website(s) and deliver the services you have requested.

DWI may also use your personally identifiable information to inform you of other products or services available from DWI and its affiliates.

Sharing Information with Third Parties

DWI does not sell, rent or lease its customer lists to third parties.

DWI may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to DWI, and they are required to maintain the confidentiality of your information.

DWI may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on DWI or the site; (b) protect and defend the rights or property of DWI; and/or (c) act under exigent circumstances to protect the personal safety of users of DWI, or the public.

Tracking User Behavior

DWI may keep track of the websites and pages our users visit within DWI, in order to determine what DWI services are the most popular. This data is used to deliver customized content and advertising within DWI to customers whose behavior indicates that they are interested in a particular subject area.

Online video streaming analytics to track watched length, bitrate, playback technology, protection, etc.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by DWI. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the DWI website.

Use of Cookies

The DWI website may use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize DWI pages, or register with DWI site or services, a cookie helps DWI to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same DWI website, the information you previously provided can be retrieved, so you can easily use the DWI features that you customized.
